



## TERMS AND CONDITIONS FOR ALL 'DRIVING COURSES' AND 'RIDE EXPERIENCES' WITH RALLYSCHOOL

Fees include GST and are non-refundable, but you may transfer to another date with greater than 14 days notice before your booked date. If your booking is made within 14 days of your booked date no changes are permitted. Full payment is payable on or before one month prior to booked course.

Participants will be required to sign an indemnity form, before commencing any course.

The booking is valid for a maximum of twelve months from the date of purchase. A transaction fee of \$3.50 will apply to each booking.

The **Customer** acknowledges that the **Company** may need to cancel courses due to unsuitable track conditions, unsuitable weather conditions, technical problems or other events beyond the **Company's** reasonable control. Scheduled dates are not guaranteed. On Rally Drive or Ride sessions, in the unlikely event that any car is damaged, in any way, such that it is not safe or possible to continue, every reasonable effort will be made to provide a back up rally car. Under no circumstances will the **Company** be liable for any consequential losses which a **Customer** may incur as a result of any such delayed or rescheduled course. The **Company** will make all reasonable endeavours to provide to the **Customer**.

For everyone's safety, the participant must advise us of any medical condition and/or allergies that could affect them during their time with us. If the condition/allergy is of a serious nature that could be a safety risk, please notify us within seven (7) days of purchase for a full refund (detailed medical certificate required). After this time there will be no refunds. However, the Gift Certificate is transferable to another appropriate participant. If an injury or medical condition occurs or becomes apparent within one (1) month of booked course date, you will need to find an appropriate replacement participant as no refunds are available. You must attend the session that you have been booked into. Not attending at the scheduled date and time will mean 100% forfeiting of the entire experience. There is a maximum height of 193cms and weight of 130kgs restriction placed on all participants. All participants must wear long pants and enclosed shoes before they will be allowed into a car.

**Please Note:** Customers need to attend the briefing session. Due to OH&S requirements, we cannot allow anyone who has arrived late and missed any portion of the briefing to participate in the experience. This will mean 100% forfeiture.

A **Customer** may be refused entry, be requested to leave the course and grounds, or if necessary, be physically restrained or removed if in the reasonable opinion of the **Company**, the **Customer** is in breach of these terms and conditions, under the influence of alcohol or drugs or, for any reason, causing a disturbance or threatens the safety of the landholders and their employees, guests, participants, staff or any property of the **Company** in any way. For the purposes of blood/alcohol analysis, a **Customer** must have zero blood alcohol concentration and may be subjected to a breathalyser test.

**Note:** Parental or guardian consent is required for all participants under eighteen (18) years of age.

The **Company** reserves the right to alter these Terms and Conditions, services offered and pricing policy at any time without further notice.

If a **Customer** causes damage to a Rally School car by not listening to an Instructor, driving recklessly, negligently or irresponsibly, the **Customer** will be liable for the damage caused.
